- 2. The School shall abide by the provisions of Right to children to free and Compulsory Education Act, 2009 and the Odisha Right to Children to free and compulsory Education Rule 2010.
- 3. The School shall admit in Class-I, to the extent of 25% of the strength of that Class, Children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion, provided, further that in case of preprimary classes also, this norm shall be followed.
- 4. For the Children referred to in paragraph-3, the school be reimbursed as per Section 12(2) of the Act. To receive such reimbursements schools shall provide a separate bank account.
- 5. The Society/School shall not collect any capitation fee and subject the child of his on her parents or guardians to any screening procedure.
- 6. The School shall not deny admission to any child for back of age proof. If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, case or race, place of birth or any of them.

 - (ii) No child shall be subjected to physical punishment or mental harassment.
 - (iii) No child is required to pass any board examination till the completion of elementary education.
 - (iv) Every Child completing elementary education shall be awarded a certificate as laid down under Rule-22
 - (v) Inclusion of Students with disabilities/ Special needs as per provisions of the act.
 - (vi) The Teachers are recruited with minimum qualification as laid under section-23(1) of the act.
 - (vii) The teacher performs its duties specified under Section 24(1) of the act and
 - (viii) The teachers shall not engage themselves for private teaching activities.
- 8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- 9. The School shall enrol students proportionate to the facilities available in the school as prescribed in the section 19 of the act.
